#### General:

By signature of this document

- I confirm to have read and understood the FIG Statutes, the FIG and IOC Code of Ethics, the FIG Code of Conduct, the FIG Technical Regulations, the FIG License Rules, the FIG Anti-Doping Rules, the World Anti-Doping Code including the International Standards, the Code of Points, the FIG Accreditation Rules and all other FIG Rules and Regulations and their amendments. I agree to comply with and to be bound by them.
- I consent that the data entered into the FIG Data-base (biographies, etc.) and collected at various occasions such as competitions (e.g. results, rankings, etc.), are published via the official FIG means.

#### Anti-Doping:

1. I have received and had an opportunity to review the FIG Anti-Doping Rules.

2. I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of the FIG Anti-Doping Rules (as amended from time to time), the World Anti-Doping Code (the "Code") and the International Standards issued by the World Anti-Doping Agency, as amended from time to time, and published on WADA's website.
3. I consent and agree to the creation of my profile in the WADA Doping Control Clearing House ("ADAMS"), as requested under the Code to which FIG is a Signatory, and/or any other authorized National Anti-Doping Organization's similar system for the sharing of information, and to the entry on my Doping Control, Whereabouts and Therapeutic Use Exemptions related data in such systems.
4. I acknowledge the authority of FIG and its National Federations and/or National Anti-Doping Organizations under the FIG Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with the FIG Anti-Doping Rules.
5. I acknowledge and agree that any dispute arising out of a decision made pursuant to the FIG Anti-Doping Rules, after exhaustion of the process expressly provided for in the FIG Anti-Doping Rules, may be appealed exclusively as provided in Article 13 of the FIG Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).
6. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.

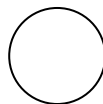
